Traffic Safety Education ~ WA State Requirements

- 1) Students must be 15 years old to be enrolled in class.
- 2) Student must obtain a Washington State Learners Permit before they can drive with an instructor.
- 3) Student must successfully complete the classroom and Driving portions of the curriculum before they will be issued a Washington State Certificate of Completion.
- 4) No student may enroll after the 3rd class.
- 5) Classroom tests and the final exam must be passed with a score of 80% or better.

If a student misses more than three (3) classes, they are required BY LAW to retake the ENTIRE (15) Classes

STUDENT EXPECTATIONS

- 1) Disruption of class will not be tolerated and you will be asked to leave with no grade for that day; the class will need to be made up.

- 6) All fees and fines must be paid before the **written final exam is taken as well as have completed class's # 1-14 and completed drives # 1-3.**
- 7) Students should bring a notebook/ binder to put class Worksheets in.

DRIVES

We recommend that you schedule one drive per week so that you can practice 4-6 hrs between drives. Parents are encouraged to ride along on drive #1 & #2. After each drive your instructor will review your progress and make recommendations for your next drive.

* Drives #1 and Drive #2 must be completed during daylight hours. * Drive #4 can either be a Review of Drives #1- 3 or upon recommendation of your instructor, you can complete an Accident Analysis Drive

* Drive # 5 is the Review for drive six

* Drive six (6) is the DOL drive.

* If we have to cancel your drive due to bad weather, there will be a notice posted on the voicemail & your drive will need to be rescheduled.

*** Drive scheduling is done by you online for a onetime fee of \$12**

**You will be charged a fee of \$40 if: 1. Giving us less than 24 HOURS NOTICE to CANCEL a DRIVE
2. Showing up for a drive WITHOUT your Learners Permit
(By LAW you are not allowed to drive without it)
3. Forgetting to Show Up for a scheduled Drive (No Show)**
